

System Ridership Report: September 2015

System-wide ridership decreased 4.1% for the month of September as compared to September 2014. SBCC ridership decreased by 14%. SBCC enrollment is down 4% from Fall 2014. Caltrans road work in the Castillo interchange caused detours and delays for Lines 5, 15x, and 16 throughout the month, which may have contributed to the SBCC ridership decrease. UCSB didn't begin Fall quarter classes until the first week of October in 2014, so there were 5 more Fall quarter class days in September 2015, which accounts for the large increase in UCSB passengers. Not counting UCSB, systemwide ridership was down 9% in September. By fare category, the biggest declines were in the use of adult passes (68% of decrease) and full cash fares, which were 32% of the decrease. Free/transfer fares account for 10% of the decline. Very hot and unusually humid weather (average temperatures for the month were 7° warmer than 'normal') may have kept people at home, or at least off of non-air-conditioned buses.

External Factors Affecting Ridership

Service Days & School Days: There were the same number of days of each service type in September 2015 and September 2014. SBCC and the secondary schools each had the same number of class days in September this year. UCSB had one less day of Summer Session and 5 more days of regular classes in September this year.

Addendum: Data Source Documentation

GFI Genfare data is taken directly from the electronic farebox system on each MTD vehicle so equipped. In general, GFI data has not been verified, modified, adjusted, added, or removed since being captured at the time of the driver/passenger transaction. GFI data is considered raw data.

Passdat program accuracy is determined by the amount of GFI farebox data that remains unchanged as compared to Trapeze Run and Trip templates for the evaluation time period. Both human and mechanical errors influence the need to make manual adjustments. These corrections are defined and determined by evaluation of historical and experiential ridership patterns.
