

System Ridership Report: August 2015

System-wide ridership decreased 5.9% for the month of August as compared to August 2014. Of the 33,605 passenger decrease, 16% was from Coastal Express Limited and Line 22 – routes that no longer exist. Another 20% of the decrease was on the Downtown-Waterfront Shuttles, and Lines 11, and 12x account for 16%, and 12% of the ridership reduction respectively. Total SBCC ridership was 25.5% above last year's, but SBCC was in session one more day in August this year. SBCC ridership increased 4.3% per class day. UCSB student ridership was little changed. By fare category, the biggest declines were in the use of adult passes (52% of decrease) and full cash fares, which were 32% of the decrease. Shuttle fares accounted for 10% of decreased ridership, while free/transfer fares account for 13% of the decline.

Addendum: Data Source Documentation

GFI Genfare data is taken directly from the electronic farebox system on each MTD vehicle so equipped. In general, GFI data has not been verified, modified, adjusted, added, or removed since being captured at the time of the driver/passenger transaction. GFI data is considered raw data.

Passdat program accuracy is determined by the amount of GFI farebox data that remains unchanged as compared to Trapeze Run and Trip templates for the evaluation time period. Both human and mechanical errors influence the need to make manual adjustments. These corrections are defined and determined by evaluation of historical and experiential ridership patterns.
