


Ridership Summary Report FY 2017-18 Annual Total

The Santa Barbara Metropolitan Transit District's (MTD's) systemwide total annual ridership totaled 6,288,980 in FY 2017-18, representing a 2.1% decrease of approximately 136,000 riders from FY 2016-17. Systemwide ridership during the fourth quarter of FY 2017-18 (April through June) totaled 1,653,016, representing a 0.6% decrease of approximately 10,000 riders from the same period of FY 2016-17.

Although MTD did see an overall decrease in ridership this fiscal year, staff is optimistic that the recent decreases may be ending. Much of the decrease from FY 2016-17 to FY 2017-18 appears to be attributable to specific causes, rather than to demographic changes or changes in mobility options.

Nearly half of the annual decrease (more than 67,000 riders) took place during the twin disasters of the Thomas Fire in December and the Montecito debris flow in January, which resulted in major disruptions to several of MTD's routes.

It is also important to note that MTD's recent ridership decreases are in line with the experiences of transit systems around the country, in California, and in Santa Barbara County.

In fact, MTD's ridership continues to represent approximately 80% of all transit ridership in the County, including the interregional services.

Student Ridership

As a whole, student ridership accounts for 36.5% of MTD's annual ridership.

University of California, Santa Barbara (UCSB) students accounted for 22.6% of MTD's FY 2017-18 ridership, and Santa Barbara City College (SBCC) students accounted for 10.5%. Thus, students of the two institutions combined make up nearly one-third of MTD's riders. School booster routes that serve Santa Barbara Unified School District (SBUSD) secondary schools accounted for an additional 3.4% of MTD's ridership.

In general, the total number of class days at these institutions has decreased over the most recent five-year period (from FY 2013-14 to FY 2017-18). Although the number of class days at UCSB increased from FY 2016-17 to FY 2017-18, as shown below, the number has decreased overall during the most recent five-year period. At SBCC, the number of combined fall and spring semester days has decreased over the five-year period, while the number of summer session days has increased. Secondary school class days have also decreased overall during the five-year period.

UCSB student ridership continued to increase in FY 2017-18, growing by more than 97,400 riders (a 7.3% increase). UCSB had four more school days in FY 2017-18 than in FY 2016-17, which accounts for a portion of the increase. The ongoing growth in UCSB student ridership illustrates the importance of continuing to provide a high level of service to UCSB and Isla Vista, in partnership with the university.

SBCC had six fewer class days in FY 2017-18 than in FY 2016-17, due to the impacts of the Thomas Fire and the Montecito debris flow. This decrease in class days accounts for a portion of the nearly 49,300 decrease (a -7.0% decrease) in SBCC student riders. Additionally, SBCC enrollment continued to decrease.

SBUSD had five fewer class days in FY 2017-18 than in the previous year, again due to the disasters. This is certainly a factor in the decrease in school booster ridership of 25,840 riders (a -10.7% decrease).

As shown in the table below, FY 2017-18 had one fewer weekday service day than FY 2016-17, and one additional Sunday service day. A comparison of average weekday ridership to average Sunday ridership suggests that this change could account for a decrease of approximately 12,600 riders.

Downtown-Waterfront Shuttle Ridership

Excluding the Downtown-Waterfront Shuttle, MTD's systemwide ridership decreased by 1.5%, or 92,720 riders (rather than 2.1% with the shuttle included).

FY 2017-18 ridership on the Downtown-Waterfront Shuttle decreased by approximately 43,100 (a -12.3% decrease) from the previous fiscal year. A portion of this decrease is due to fewer cruise ships stopping in Santa Barbara. There were 23 cruise ships served by MTD in FY 2016-17, compared to 15 in FY 2017-18. With an estimated cruise ship ridership of approximately 450 additional riders per visit, this decrease in cruise ship visits could account for 3,600 fewer passengers. In addition, the Thomas Fire negatively affected ridership on the service. Downtown-Waterfront Shuttle ridership in December 2017 was 25.9% lower than December 2016.

MTD will continue to work in partnership with the City to increase ridership on the Downtown-Waterfront Shuttle. The new day pass for the service, debuting this fall, is one such effort.
