SUBJECT: MICROTRANSIT VEHICLE ACQUISITION RECOMMENDATION

RECOMMENDATION:

Based upon the discussion that follows, staff requests that the Board of Directors give the General Manager authority to provide a purchase order (PO) to use the California Association for Coordinated Transportation (CalACT) purchasing cooperative with A2Z Bus Sales for the purchase of three (3) 2020 Ford Transit 350EL diesel vans for a fixed price of \$255,581.04.

DISCUSSION:

MTD applied for and has received funds for the operation of a one year Microtransit pilot through the State of California's Low-Carbon Transit Operations Program (LCTOP). Microtransit is ondemand, flexible, curb-to-curb service within a specified zone and requires a smaller and more nimble vehicle than a standard 30 or 40 foot long transit vehicle. The Ford Transit 350EL is well-regarded and has been used for this application by other transit agencies across California.

As a cost-effective and expeditious method of light-duty vehicle procurement, staff turned to the CalACT's well-regarded purchasing cooperative that is frequently used by small transit agencies around California. Santa Barbara MTD recently became a member of CalACT, which allows access to this purchasing cooperative. CalACT's agreement has a wide range of vehicle types, including vans. Staff narrowed their search to non-cutaway vans with ADA lift/ramp access and sufficient ambulatory passenger seating (over 6 seats). Staff first attempted to find an electric or hybrid gasoline version of this vehicle type. Electric vehicles of this type were not readily available and could not be procured quickly. Hybrid kits for Ford Transit vans do exist, but the one company that supplies the hybrid kits were completely over-subscribed and had ceased taking orders.

Since this project's operation is being funded by LCTOP funds, whose goal is to reduce emissions, staff found that by using renewable diesel, our emissions were greatly reduced from the original fuel type of hybrid gasoline. Since MTD's diesel fuel supply is set to become renewable diesel on December 1, 2019, staff decided to pursue a diesel engine for this van procurement.

CalACT's cooperative purchasing agreement had three approved vendors for the Ford Transit 350EL: A2Z Bus Sales, Creative Bus Sales, and RO Bus Sales. Staff reached out to each to request a quote with the layout and specific options needed for MTD's purposes. While all vendors have Ford Transit vans available and vetted through the purchasing cooperative, A2Z Bus Sales was deemed the most desirable for a few reasons. A2Z and their upfitting contractor NorCal Vans

build using a passenger van base vehicle, unlike others who use a cargo van base vehicle. This means that A2Z's vehicles have side curtain airbags standard in the passenger compartment. Additionally, A2Z was extremely responsive and was able to provide the optimal layout with a sliding lift and ramp, 7 ambulatory passenger seats, and a storage box for passenger belongings like groceries.

Neighboring agency Gold Coast Transit recently procured the same vehicles for on-demand and ADA paratransit purposes, and they are pleased with their purchase. Gold Coast also procured their vehicles through the CalACT purchasing cooperative with A2Z Bus Sales.

PROJECT BUDGET & FUNDING:

The pricing for these three vans include the base price of the vehicle, with added options including a Slide-n-Step wheelchair lift/ramp, flexible passenger seating, 4 camera video surveillance system, retractable running board, and storage box. Each vehicle with total options selected plus tax and a CalACT fee of 1.5% on the subtotal is priced at \$85,193.68. The purchase price, delivered for three (3) Ford Transit 350EL diesel vans is \$255,581.04.

SOLICITATION PROCESS:

<u>CalACT Purchasing Cooperative</u> - California Association for Coordinated Transportation (CalACT) is a professional association representing small, rural, and specialized transportation providers statewide. CalACT manages a purchasing cooperative that provides a federal and California state compliant purchasing solution. CalACT conducts formal solicitation activities that result in cooperative agreements with favorable pricing. CalACT's methodology is thorough and comprehensive, and each vendor is thoroughly audited and supporting documents are maintained on CalACT's website. This method significantly reduces the procurement time and resources in acquiring the needed equipment or services that require a formal solicitation and includes the added benefit of volume pricing. Staff reviewed the procurement documents and procedures from the CalACT solicitation for Class V vans, and found them to be in conformance with MTD's requirements.

<u>Price Analysis</u>—Adequate price competition is one of the six price analysis techniques listed in the *Pricing Guide for FTA Grantees*. Adequate price competition is dependent on the following: 1. At least two responsible offerors respond to a solicitation. 2. Each offeror must be able to satisfy the requirements of the solicitation. 3. The offerors must independently contend for a contract to be awarded to the responsive and responsible offeror submitting the lowest evaluated price. 4. Each offeror must submit priced offers responsive to the expressed requirements of the solicitation. The CalACT Request for Proposals for a Joint Procurement for Accessible Transit/Paratransit Vehicles process meets all 4 of these requirements.

If staff conducted its own formal procurement and those expenses were calculated into the per unit vehicle price, it is likely that method would also result in higher costs for MTD compared to the CalACT pricing. As a result, Staff find A2Z Bus Sales' \$55,511.70 base price for a 2020 Ford Transit 350EL Diesel Van under the CalACT RFP #15-03 to be fair and reasonable.

PROJECT IMPLEMENTATION:

If the Board gives the General Manager authority to provide a PO allowing the purchase of three (3) Ford Transit 350EL diesel vans via the CalACT purchasing cooperative, the order will be sent to A2Z Bus Sales via CalACT's process, and will be added to the production gueue for early 2020.

SUBJECT: PROPOSAL FOR A ONE-YEAR SBCC TRANSIT PASS RENEWAL

RECOMMENDATION:

Staff recommends that the Board authorize General Manager Estrada to sign an Agreement with Santa Barbara City College (SBCC) to continue the student transit pass program for one year through the end of the spring term of calendar year 2021.

DISCUSSION:

MTD and SBCC have a long-standing agreement whereby SBCC students pay a fee to MTD each term and in return can ride MTD fixed-route buses for no additional charge (with the exception of the Downtown-Waterfront Shuttle). The agreement has been renewed several times. The most recent two-year renewal will expire at the end of the spring term of calendar year 2020.

At the current fee of \$32 per student for each fall and spring semester and \$14 per student for each summer session, the return to MTD per ride is consistent with the Board's goal that the return should be comparable to the fare available to other MTD passengers.

Staff proposes to offer to renew the agreement for an additional one-year period (through the end of the spring term of calendar year 2021) at the current fee. Dependent on comments from the Board, staff will next present the proposal to SBCC administration, which has expressed support for the proposal.

Operations, Fleet & Facilities

Work on the first phase of the Transit Center Renovations Project began the week of July 15. Since that time, MTD's contractor, Newton Construction, removed and relocated benches, trash receptacles, and newsstands; removed block walls and landscaping; poured concrete pads for new boarding and alighting positions; trenched and ran conduit for fiber optic cabling and a new electrical service; and placed and secured all temporary structures.

The transition from the Transit Center to the temporary facilities took place over the week of September 2nd, with the official closure of the Transit Center and use of the temporary facilities and boarding zones starting on Sunday, September 8. Staff from all departments and supervisors participated in various aspects of the move.

During the first week of operations from the temporary facilities and boarding zones there has been a large operations staff and supervisor presence to support passengers, bus operators, and MTD personnel working out of the temporary facilities. While there have been some adjustments, overall, passengers and MTD personnel appear to be adapting to the new arrangement.

IT staff worked to ensure a smooth transition of technical systems to the temporary TC facility. These included voice and data communications, security cameras, and the public address system. Similarly, fare revenue collection staff worked long hours to successfully move and level the extremely heavy and cumbersome ticket vending and change machines to their temporary locations. All IT and fare equipment was operational upon opening Sunday morning.

Marketing and Community Relations staff assisted in preparations for the Transit Center project and transition to temporary facilities. Customer Service Representatives have adapted to the new conditions and are assisting the public in learning the new boarding zones. In advance of the transition, staff used social media and our dedicated Transit Center project website to update the public. Thus far, feedback from riders has been positive.

Although challenging, this project has brought out the dedication, determination, and team spirit of MTD personnel.

BYD was here for three days in early August providing first responder training for our local first responders and employees. The feedback from those in attendance was all positive. BYD is scheduled to return in September to provide diagnostic training for our mechanics.

As of this week, twelve of fourteen BYD's are in service. Two BYD buses are currently at BYD's factory in Lancaster undergoing warranty repairs and software updates. This is part of a campaign to return all BYD buses back to the factory. Originally, we were returning one bus at a time but now due to the reduced fall schedule we are able to return two buses at a time. Currently, seven of fourteen are completed. The remainder of the fleet is scheduled for completion by October 7th.

Hybrid bus 908 underwent hybrid system repairs at Valley Power and is now back in service. Hybrids buses 903 and 909 remain out of service for similar repairs. Hybrid bus 905 had its

transmission fail. The transmission was sent to Valley Power in Mira Loma Ca. for overhaul and the bus is now back in service. Hybrid bus 904 lost an engine and is currently in the shop getting its engine replaced.

All ten of the new Gillig 40-ft. buses are performing well and the operators seem happy with them.

All surplus Nova bus parts from the parts room have been auctioned and are awaiting pick up by the new owners. The freed-up space will now store our BYD spare parts.

Six Ebus shuttles remain with three currently in service; the other three are being prepped for auction.

Staff submitted two grant applications to the 2019 Clean Air Grants program of the Santa Barbara County Air Pollution Control District. One application is for the On-Road Vehicle Program, to assist in the purchase of one 40-ft. electric bus, and the other is for the Infrastructure Program, to assist in the purchase of the 14 service vehicle chargers.

Staff submitted the paperwork to the California Air Resources Board's Clean Vehicle Rebate Project for a \$2500 rebate for each Chevrolet Bolt on order. MTD's application is still pending.

MTD issued a purchase order to ChargePoint, Inc. for fourteen CT4011 single port commercial chargers. The CT4011 is the same model as the charger in the front parking lot at Terminal 1. Staff used a cooperative purchasing contract from Sourcewell for the procurement.

Southern California Edison's (SCE) Charge Ready Program team has completed the preliminary design of the new electrical infrastructure for the EV chargers. After staff approved the preliminary design in mid-August, SCE's design team began working on the final design. Once completed, SCE will submit to the City of Santa Barbara for permitting.

Stantec, MTD's consultant for the Facilities Master Plan (FMP), organized a kickoff meeting and visioning session with members of the Facilities Master Plan Ad Hoc Committee and other stakeholder groups on July 24 and 25. The week of August 12, a large team of Stantec architects and engineers performed a detailed assessment of structures and building equipment at Terminals 1 and 2. The information gathered will be included in a summary report that will be the basis for recommendations in the FMP.

Administration

Staff submitted the July and August monthly ridership and safety and security reports to the Federal Transit Administration's National Transit Database, as required.

Staff submitted the required semiannual reports to Caltrans on the ongoing Transit Center rehabilitation project and the 30-ft. electric bus project for Proposition 1B grants received from the Public Transportation Modernization, Improvement, and Service Enhancement Account (PTMISEA).

Staff participated in two SB 1 Programs Metrics Workgroup webinars held by the California Transportation Commission. The Workgroup is working to develop standard metrics that will be used to measure the success of public transit projects funded by various competitive SB 1 programs, as required.

Staff participated by phone in two meetings of the Transportation Emergency Preparedness Plan (TEPP) Advisory Committee. The TEPP is a joint project of the Ventura County Transportation Commission (VCTC) and the Santa Barbara County Association of Governments (SBCAG). The TEPP was funded following the twin disasters of the Thomas Fire and the Montecito Debris Flow.

Staff attended a meeting of the Santa Barbara County Association of Governments' (SBCAG's) Joint Technical Advisory Committee (JTAC) and Technical Transportation Advisory Committee (TTAC) on September 5. TTAC recommended that the SBCAG Board approve changes to the Measure A Financial Memorandum and approve the use of Regional Surface Transportation Program (RSTP) funds for the environmental and permitting phase of the Olive Mill and San Ysidro roundabouts. JTAC recommended that the SBCAG Board approve a contract with the Community Environmental Council for public participation facilitation during the preparation of the Regional Transportation Plan - Sustainable Communities Strategy (RTP-SCS) update.

MTD's Manager of Human Resources & Risk, Mary Gregg, attended the FTA's Public Transportation Agency Safety Plan (PTASP) workshop held in Atlanta, GA in late July. The workshop was designed specifically for Bus Transit Agencies, focused on the requirements for compliance with the PTASP rule (49 C.F.R Part 673). The workshop covered strategies for development, certification and implementation of an Agency Safety Plan, which is required to be in place by July 20, 2020. Risk will present a detailed update on PTASP and the workshop to the Board at a future date.

The cash report includes a certificate of deposit for the first time in a few years. The benefit of a CD (or similar instruments) is that the interest rate is locked in for specified period of time. This is deemed prudent in the current environment of falling rates. Technically, it is not a certificate of deposit but rather an American Riviera Bank deposit account that guarantees the 2% rate of return for the 18-month period.

With the completion of the video server upgrade for facility security cameras, the storage capacity has been increased to a year. Prior to the upgrade, the capacity was 30 days. This is made possible through larger storage drives as well as improvements in video compression methods. A number of new cameras have been installed as part of the upgrade in order to fill gaps in coverage for improved security and safety. With the original cameras in service for nearly a decade, the newer cameras are superior using digital technology for higher resolution and the improved compression. MTD is also making use of cameras with a 180° field of view, which reduces the number of cameras required for a given area.
