# 6. PLANNING DEPARTMENT SERVICE WORK PLAN UPDATE - (INFORMATIONAL)

Planning and Marketing Manager Hillary Blackerby presented the Committee with an update on the Service Work Plan for August 2020.

While recognizing that the Service Work Plan Update was an informational item, Committee Member Davis initiated the following motion: to support the Traffic Management Plan (TMP) Proposal for the 101 High Occupancy Vehicle (HOV) Project mitigation program serving Carpinteria, Santa Barbara's Eastside neighborhood, and Santa Barbara City College (SBCC), and to support a contingency fund for possible impacts to the Line 20 service during freeway construction. Bill Shelor seconded the motion and noted that the proposed TMP plan aligns with MTD's following Strategic Plan goals: work with partner agencies to ensure adequate traffic management, and support mode shift to reduce traffic congestion. The motion passed unanimously.

#### DISCUSSION:

Planning staff are currently working on a draft of proposed service changes for August 2020.

The following items are under consideration at this time:

- Minor changes to improve weekend on-time performance for Lines 20 (Carpinteria) and 36 (Seaside Shuttle)
- Minor changes to improve on-time performance on Line 28
- Continued improvement to express nature of Lines 12x & 24x
- New line through agreement with SBCAG for a Traffic Management Plan project for the upcoming 101 HOV Project, serving Carpinteria, SB's Eastside, and Santa Barbara City College
- Microtransit pilot in Goleta

Planning staff will also continue to monitor on-time performance, operational efficiency, and changing conditions on all other lines and services.
