

Invitation for Bids for Haley Canopy Zero-Emission Vehicle (ZEV) Infrastructure Improvements Addendum Number 2 – Issued May 30, 2025

The Santa Barbara Metropolitan Transit District (MTD) issues this Addendum Number 2 to its Invitation for Bids for Haley Canopy Zero-Emission Vehicle (ZEV) Infrastructure Improvements (IFB) issued on May 12, 2025. This Addendum provides clarification for Bidders and a revised bid due date. This Addendum is now incorporated into and part of the IFB. Except as modified by Addenda, all other terms and conditions of the IFB remain unchanged.

New Bid Due Date:

Sealed bids will be received **until Monday, June 16, 2025, at 2:00 PM (local time)**, at 550 Olive Street, Santa Barbara, CA 93101, where bids will be opened and read aloud.

Job Walk Feedback

- **Phasing of Work Activities/Coordination with MTD Operations:**
Based on logistical questions posed during the mandatory Pre-Bid Meeting and Job Walk (May 21, 2025), related to executing construction activities alongside MTD operations, MTD is developing a coordination plan that will provide more detailed direction on how construction activities must be approached to allow MTD operations to continue unimpeded. The plan will be issued in a future addendum, and will include changes to the solicitation and construction schedules. The below update to the Solicitation Instructions is the first of those changes and goes into effect immediately.

Bid Delivery

➤ **Monday, June 16, 2025 2:00 PM PDT**

Bids will be accepted until 2:00 PM local time on Monday, June 16, 2025. It is the Bidder's sole responsibility to ensure that the bids are received by the date and time stated above.

- **Project Work Hours:**
This project's work hours have changed from 7:00 p.m. to 3:30 p.m. This updates the Project Manual, General Conditions 01 10 00 – 4 (1.07 Work Restrictions):

Job Walk Feedback (cont.)

B. On-Site Work Hours: Limit work to normal business working hours of 7:00 a.m. to 3:30 p.m., Monday through Friday, unless otherwise indicated or restricted by the City of Santa Barbara.

- **Internet/ Plan:**
Any necessary internet and Wi-Fi access for the Contractor's operations, personnel, and equipment at the Project site needs to be supplied by the Contractor. Contractor shall not utilize MTD's internet or network resources.
- **Security Cameras:**
Contractor acknowledges that the Project site, including designated work areas, may be under surveillance by MTD-owned security cameras. This surveillance is for MTD security purposes. Contractor is responsible for informing its personnel and subcontractors of this condition.
- **Lead Paint Concern:**
The project site areas were constructed and painted after 1991, so there are no known lead-based paint hazards.
- **Gutters:**
This confirms that the gutter replacement work is to be included in the bid. MTD will not supply new gutters.
- **Maintenance Canopy Scope – only cellular repeaters:**
This confirms that the Maintenance Canopy scope is the bid alternate. The work for the maintenance canopy is for the cellular repeaters only; there is no lighting or painting.

Bidder Question

The bid documents state Bid Bond for 5% of bid, however there are no Bid Bond forms. Will these be provided or to be provided on a generic bid bond form from Bond Surety?

Yes, bid security of 5% of the Base Bid Price is required to be included in the Bidder's submittal. See Solicitation Instructions.

Bid Security & Bonds—

MTD does not have its own Bond form; Bidder can use the AIA Standard Bid Bond form or another similar bond form supplied by a legitimate surety company.
